SUBJECT: Acknowledgement Agreement for Non-DoD Civilian Access to Holloman AFB

1. The purpose of this memorandum is to provide specific rules on Holloman AFB access program for non-DoD Civilians.

2. Non-DoD civilians will:

a. Only enter approved locations:

- (1) Ace's Ten Pin Cantina/Desert Lanes Bowling Center
- (2) Club Holloman
- (3) Apache Mesa Golf Course
- (4) Oasis Pizzeria & Sports Bar
- (5) Heritage Park and Museum

b. Only remain on base when approved locations are open.

c. Follow all traffic signs and posted speed limits.

d. Not drink and drive on the installation.

e. Not bring any weapons onto the installation.

f. Be aware that persons, vehicles, and property are subject to search before entering or leaving the installation.

g. Not take photographs of aircraft or facilities while on the installation.

h. Follow all requirements in Attachments 1 and 2 to this memorandum.

i. Be aware that Holloman Air Force Base is not an open forum for free speech and the Installation Commander has not opened the base to protests, public proclamations, political activities, unauthorized business solicitations, rallies, religious or ideological demonstrations, and other types of activities typically associated with free speech. As a military installation, the maintenance of good order and discipline is necessary for effective mission accomplishment and any activities must be consistent with fulfilling the units' responsibilities.

3. The authorized routes of travel are highlighted on the attached map (Attachment 1). All shaded areas are off-limits for non-DoD civilians. The following roadways may be used to access the approved locations:

- a. First Street: from the Main Gate to the intersection of Idaho Avenue.
- b. Idaho Avenue: from First Street to the intersection of Sixth Street.
- c. New Mexico Avenue: from First Street to the intersection of eleventh Street.
- d. Arizona Avenue: from First Street to the traffic circle of Eleventh Street/West Gate Avenue.
- e. West Gate Avenue: from the West Gate to the traffic circle of Eleventh Street/Arizona Avenue.
- f. Eleventh Street: from the traffic circle of Eleventh Street/West Gate Avenue to New Mexico Avenue.
- g. Sixth Street: from Arizona Avenue to Idaho Avenue.
- h. Fourth Street: from New Mexico Avenue to Idaho Avenue.

4. Violations of any of these rules are subject to expulsion as a “Friend of Holloman” without reimbursement, barment from the installation, as well as prosecution under Titles 10 and 18 of the US Code of Federal Regulations.
